With more stores offering extended hours for senior citizens and those with underlying medical issues, we want to help you get there safely.

Stop F Cardenas is dedicating 7 to 8 a.m. each day to vulnerable shoppers. This route provides service to Cardenas on Wednesdays and Fridays.

Stop J Smith's is dedicating 7 to 8 a.m. on Mondays, Wednesdays and Fridays to vulnerable shoppers. This route provides service to Smith's on Wednesdays and Fridays.

Fare for this route is \$.50 for each boarding. Full and reduced fare fixed route bus passes are also accepted.

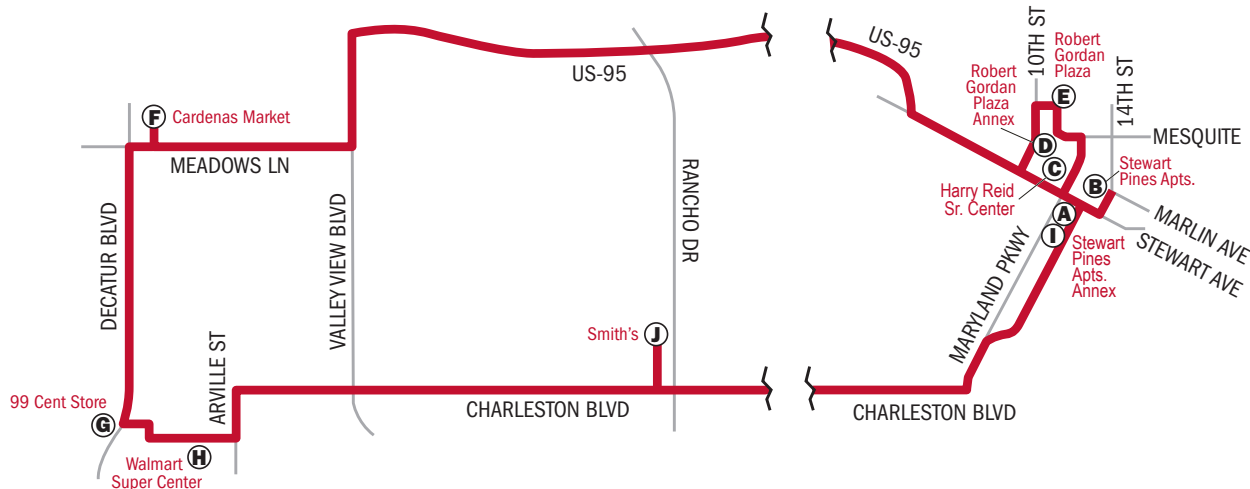
