Due to the COVID-19 pandemic, the RTC has seen a sharp decrease in critical funding and has proposed several transit service changes to help adjust for this revenue loss. Before a final plan is approved, we need to hear from the community.

A 60-day public comment period will remain open through Friday, Aug. 28. All details are available online at rtcsnv.com, posted on all transit vehicles and available at transit centers. RTC staff will continue to provide in-person outreach opportunities at busy stops and transit centers throughout the comment period.
